

# Student Services and Amenities Fee (SSAF) 2023 Allocation Report

The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister.

Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this SSAF Allocation Report does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial Viability Instructions: Applicants and Providers of FEE-HELP (FVI)</u> for all other approved providers.

#### **SSAF Consultation and Achievements**

In accordance with Murdoch University Act 1973 (20A, (3)) no less than 50% of the SSAF fee collected is allocated to the Guild. Allocations also provide Health and Counselling, Student Success, Sports and Recreation opportunities. The remainder is distributed as project funding. Each project initiative is assessed to ensure that it complies with Commonwealth legislative requirements regarding the administration of the SSAF.

In 2023 SSAF funding enabled many achievements:

- Counselling services employed professionals (3.3 FTE) who provided 1,656 counselling sessions to 336 individual students and delivered over 500 workshops and education sessions relating to wellbeing and inclusion throughout 2023. The University also funded an International Student Mental Health initiative to provide counselling services to international students and consultation support to the University's counselling staff members.
- Murdoch developed "The Den" (previously "The Living Room") project for students to build a sense of connection and belonging at the University by offering centralised, easily accessible, and diverse wellbeing services. The number of Den sessions has increased 4 days a week in 2023. Students can participate in free mindfulness activities and creative arts, enjoy herbal tea, music, board games or play with therapy dogs. Weekly International Café Day was also introduced in 2023 which has proven to be a popular initiative to connect international students and support their orientation and wellbeing at Murdoch.
- Student Success teams provided advice on navigating the University systems and support services. The team
  assisted international students in completing 2,283 other applications/administrative processes related to
  compliance to ensure those students remained compliant with their visa conditions and assessed and processed
  2,413 applications for the International Student Accommodation Subsidy (ISAS) on behalf of the WA
  Government. Student Success team also developed an intervention strategy to provide international students
  with dedicated support to improve their overall progression rate.
- Murdoch Active used SSAF funds to provide opportunities for sports and recreational activities, subsidised
  membership fees, facility hire charges and school holiday programs for primary school aged children of students,
  provided employment opportunities to students to manage the School Holiday Program. Murdoch Active also
  provides placement opportunities to 3<sup>rd</sup> year Exercise Science students to complete the required practicum hours.
- In 2023, eight students benefitted from the SSAF funded Elite Athlete Program. The funding has evidently played a crucial role in enabling these individuals to participate and compete in their sports on a global stage.
- SSAF funded a Clinical Psychologist to provide counselling appointments and develop and deliver workshops specifically for International Students. The role also provides consultation and support to the University's counselling staff members in providing clinical interventions for international students.
- Funding was also provided to support the Students as Change Agents (SCA) program, a co-curricular program
  that empowers students to propose, lead and implement a project to create positive change at Murdoch
  University (MU). This program provides opportunities to students have a dedicated mentor to develop their ideas
  into project plan, to implement, to present to both internal and external stakeholders. The program also allows
  student to receive credit towards their degree if applicable.

SSAF funds was provided to provide casual employment to students as Kulbardi Student Ambassadors to work
closely with Aboriginal and Torres Strait Islander students / prospective students, to assist in their progression
into the University and provide ongoing support while studying at the University. The University has also provided
sponsorship to 13 students and 2 staff members to participate in the Indigenous Nationals, a multi-sporting
competition for Indigenous Student Athletes.
